(g) Item 11(b) - EU Regulation (EC) No 1107/2006 –people with reduced mobility

The Facilitation Working Group of the *European Civil Aviation Conference* (ECAC) has now adopted Guidelines on Awareness and Disability Equality setting out the general principles recommended for staff dealing directly with the travelling public. They have become a new Annex N to ECAC Document 30 on Facilitation and will serve as guidance for airport staff training. 5. CHANGE OF OWNERSHIP

Members have been previously informed of the agreement signed on 11th October 2006 for the sale of the Airport to a consortium comprising the AIG Financial Products Corporation, a wholly owned subsidiary of American International Group Inc., leaders in insurance and financial services, and Global Infrastructure Partners, an infrastructure joint venture between Credit Suisse and GE Infrastructure. The transaction was subject to EU merger clearance which was given on 24th November and the acquisition was completed on 30th November 2006

11. LIMITS ON AIR TRANSPORT MOVEMENTS – TEMPORARY VARIATION

At the last meeting the Airport Director reported that the Airport had applied to the London Borough of Newham as the local planning authority temporarily to vary the present limits on air transport movements to allow more movements Mondays to Fridays but with a corresponding reduction in the limit on movements on Saturdays and Sundays and during quieter holiday times. The overall annual limit of 73,000 movements would not be changed. The application (06/01310/VAR) can be seen on the Council's website⁵.

On 10th November the Secretary notified members that the Airport's application was to be considered at a meeting of the Council's Development Control Committee on 14th November 2006 and circulated the text of the relevant Agenda item and a copy of the officer's report on the application. Later, however, members were notified that the Airport had been informed that legal advice was required in connection with the application and accordingly that the report would not after all be considered by the Development Control Committee at its November meeting. Information is now awaited about the date on which the application is to be considered - the present indications are that the application might be considered on 10th January 2007 but this has still to be confirmed.

Meanwhile, the Secretary has been in correspondence with the Council's officers concerning consultation on such applications. In spite of a request for information sent to the Council on 5th October, and again on 23rd October, the Committee – a key stakeholder - received no information whatsoever about this application although it would appear from the officers report on the application that more than 600 letters were sent to other interested agencies and individuals. This has attracted an apology from the Council's officer who say they will ensure that future applications go through the Committee either from the Airport or ourselves [i.e. the Council] once planning applications are lodged. The Secretary has responded that as a matter of routine the Council should consult the Committee directly about all applications submitted by the Airport or airport related organisations or which might have a significant impact on airport operations and asked if arrangements can be made for this.

12. ANNUAL MEETING OF AIRPORT CONSULTATIVE COMMITTEES

A copy of the official minute of this meeting, held at Manchester on 21/22 June 2006, has been circulated to all members. The 2007 Meeting is to be held at Stansted Airport on 13/14 June.

The annual meeting is attended by the Chairmen and Secretaries of committees participating in the Liaison Group of UK Airport Consultative Committees (UKACCs). This is currently made up of the ACCs at the 22 largest UK airports and another four are now eligible to join if they so choose– for more information visit the Group's website⁶

13. PUBLIC SAFETY ZONES - REVIEW

The Department for Transport has indicated that during 2007 it will commence a review of established PSZs. The intention is to begin with those airports which have seen the most significant growth since 1999/2000

14. AIRBUS A318

Among the aircraft currently under consideration for use on routes serving London City Airport is the Airbus A318. This aircraft paid a visit to the Airport for compatibility tests on Saturday 14th May and again on Saturday 29th October 2006 when members were informed

of the trials in advance. The aircraft used on the latter occasion was fitted with the latest technology engines and carried 56 tonnes, representative of the load it would take from London City under normal operations - on this basis the Airport would not expect the aircraft to be noisier when carrying passengers and freight in ordinary service.

On 29th October the trials were observed from across the Dock by a group from the Beckton Community Forum. Their verdict was:

“The engineers and designers have successfully developed an aircraft that has more powerful engines, takes more passenger further is therefore bigger and quieter. On our way back we called in to the local corner shop (approx 1000yds away) and asked the owners and customers about the new aircraft noise and they said - what noise?”
